

## Dear Applicant,

Thank you for your interest in the Kiwanis Village Society. We provide independent living apartments at below-market rates for adults 55 and older in Powell River.

We invite you to apply for a comfortable one-bedroom or studio suite in our well-maintained building. The demand for below-market rental units is high and, at the present time, the Village is fully occupied. Once your application has been received and evaluated, we will contact you for further information or add your name to the applicant pool. Unfortunately, we are not able to predict how long it may take before an apartment becomes vacant. This depends on factors that are outside the control of Kiwanis.

To qualify for housing with Kiwanis, you must meet the criteria listed below. The income and asset limits must be met throughout the tenancy, and we will perform income verification before your tenancy begins and annually thereafter.

## **Eligibility Criteria:**

- 55 years or older at the time of application.
- Capable of living independently without the need for services provided by Kiwanis.
- Single residents only (no more than one person per apartment).
- A non-smoker (for any substances). The entire property is non-smoking.
- Resident of British Columbia for at least 12 months at the time of application.
- Gross Income less than \$84,780 for the household. This figure is for applications in 2025 and subject to change as the Low- and Moderate-Income Limits, determined by BC Housing, are updated annually.
- Assets not exceeding \$500,000.
- Proof of renter's insurance, including a general insurance liability clause of \$1,000,000, is required at move-in.
- Small dogs are only allowed on the first floor. Other small pets allowed on all floors.
